Note: As per Rule 76 (13) which states If a Financial Member expects to be absent at the time of the election from their address appearing in the Register of Members that member is entitled to have a ballot paper forwarded to another address the member nominates, or handed to the member personally, on the member making written application to the Branch Returning Officer not later than three (3) days prior to the opening of the ballot.
